## A Bill to Provide Hormonal Contraceptives

BE IT ENACTED BY THE CONGRESS HERE ASSEMBLED THAT:

- SECTION 1.** The US will provide 500 million dollars to the countries that show the most need for subsidized hormonal contraceptives
- SECTION 2.** Hormonal contraceptives will be defined as birth control method that act on the endocrine system that prevent pregnancy. The most need is defined as countries with the highest percentage of women who have an unmet need for hormonal contraceptives.
- SECTION 3.** The department overseeing the enforcement of this legislation is the United States Agency for International Development (USAID)
- SECTION 4.** The USAID will start accepting application one year in and then start supplementing them in two years
- SECTION 5.** All laws in conflict with this legislation are hereby declared null and void.

**A Bill to Stop Military and Economic Aid to Foreign Countries  
Harboring Terrorists**

BE IT ENACTED BY THE CONGRESS HERE ASSEMBLED THAT:

- 1 **SECTION 1.** Military and Economic aid shall be cut off from countries harboring known  
2 terrorists or terrorist groups.
- 3 **SECTION 2.** Military aid shall be defined as any weapons or combatants such as tanks,  
4 war planes, soldiers/advisors, and ammunition. Economic aid shall be  
5 defined as any monetary awards based on needs of a given country.  
6 Terrorists and/or terrorists groups shall be defined as individuals or  
7 organizations whose purpose to support an agenda which is contrary to the  
8 United States' values of life, liberty and the pursuit of happiness by creating  
9 threats or through coercion.
- 10 **SECTION 3.** The Department of Defense (DoD) shall oversee the enforcement of this bill  
11 under the guidance of the United States Department of State.
- 12 **SECTION 4.** This bill shall take effect January 1, 2017.
- 13 **SECTION 5.** All laws in conflict with this legislation are hereby declared null and void.

**A Bill to Destabilize the C.S.T.O**

BE IT ENACTED BY THE UNITED STATES CONGRESS HERE ASSEMBLED THAT:

SECTION 1. For the purpose of this bill, the following definitions shall apply:

SUBSECTION A. The "C.S.T.O" is defined as the Collective Security Treaty Organization. The nations that are "members of the C.S.T.O" should be defined as all non-founding members within the sphere of Russian influence. These nations include: Armenia, Belarus, Kazakhstan, Kyrgyzstan, Tajikistan, Afghanistan, and Serbia.

SUBSECTION C. The term "trade sanctions" will be defined as one or more trade barriers that a country places upon another country as a punitive action.

SECTION 2. The purpose of this bill is to establish a loan program for C.S.T.O members to minimize their individual national debts.

SECTION 3. Upon passage of this bill, the United States Federal Government will act as follows:

SUBSECTION A. The U.S. will review the C.S.T.O members that apply to this program and has the ability to deny the loan if deemed necessary by the U.S. Department of Treasury.

SUBSECTION B. The U.S. Treasury shall look over the distribution of loans and repayment from these loans given to member nations.

SUBSECTION C. The U.S. will give a loan to the C.S.T.O member which covers 10% percent of its debt. After a two year grace period, a payment plan will be organized by the U.S. Treasury and C.S.T.O recipient.

SUBSECTION C. The interest rate, through a fixed rate loan, given on the loan shall not be lower than a rate of 1.5% and no higher than 6%.

SUBSECTION D. Nations that apply for this program cannot re-apply until the nation has repaid their previous loan from this program.

SECTION 4. The United States Department of Treasury will oversee plan and distribute loans per the U.S. foreign loan policy.

SECTION 5. Any C.S.T.O member that does not repay the loan with the negotiated payment plan will be subject to trade sanctions on the discretion of the current leadership of the United States. All laws in conflict with this legislation are hereby declared null and void.

SECTION 6. This bill will be implemented on January 1st, 2020.

- 9 **SECTION 4.** This bill will go into effect July 1st, 2019
- 10 **SECTION 5.** All laws in conflict with this legislation are hereby declared null and void.

6. **SECTION 3.** The Environmental Protection Agency and the Department of Agriculture
7. will oversee the enforcement of this bill. The Department of Agriculture
8. will assist in the accommodations needed for farmers' subsidies.
9. **SECTION 4.** The implementation of this bill shall take place on June 1st, 2019.
10. **SECTION 5.** All laws in conflict with this bill shall hereby be declared null and void.

### A Bill to Ban Legacy Preferences in Colleges

BE IT ENACTED BY THE UNITED STATES CONGRESS HERE ASSEMBLED THAT:

1. SECTION 1. Any college receiving funds from the U.S. federal government
2. shall hereby be banned from factoring legacy status in the
3. admissions process.
4. SECTION 2. Students applying for federally funded colleges will no longer
5. be allowed to present their legacy status anywhere within
6. said school's application.
7. SECTION 3. "Legacy status" shall be defined as any prospective student whose legal
8. guardian is an alumnus of the applied school.
9. SECTION 4. The U.S. Department of Education will oversee the
10. implementation of this bill.
11. SECTION 5. This bill will be implemented on January 1st, 2020.
12. SECTION 6. All laws in conflict with this legislation are hereby declared null
13. and void.

## A Bill to Parent our Parents

1 BE IT ENACTED BY THE UNITED STATES CONGRESS HERE ASSEMBLED THAT:

2 **SECTION 1.** A mandatory parenting class shall be enforced throughout the United  
3 States. Classes must be completed before the child is released into the  
4 parents' care. Classes are to be offered in High School as well as any  
5 public care facilities.

6 **SECTION 2.** "Parenting Class" is defined as a course that covers the basics of child  
7 care; providing food, clothing, shelter to minors, as well as basic first aid  
8 training. Parents will also have to undergo training to avoid mental and  
9 physical abuse of children.

10 **SECTION 3.** This bill will be enforced by the US Department of Health and Human  
11 Services.

12 A. Records will be kept in a database accessible to all hospitals, doctors,  
13 and schools.

14 **SECTION 4.** This bill is to be enacted on January 1<sup>st</sup>, 2021

15 **SECTION 5.** All laws in conflict with this legislation are hereby declared null and void.
